#### NOTES

The accounts for this year contain a £500 payment from the Fisher Memorial Trust for IBC 2012 bursaries. There was also one extra bursary of £250 paid out.

There are a number of outstanding liabilities with respect to the Channel Network Conference: travel expenses for two speakers (c. £1500); further conference expenses with the University of St Andrews (c. £3000). In addition, the likely surplus from the meeting is to be distributed between the four Channel regions, less a "float" of the order of €5000 which we received from the previous Conference and will in due course pass on to the organisers of the fifth Conference. In the table below, please note that the figures for the Channel Network Conference only relate to the 2012/13 financial year, and that a final summary will appear in the Financial Report for 2013/14.

Transactions associated with meetings, occurring in the 2012/13 financial year, are shown below. Note the income and expenditure totals do not match the above figures exactly as transactions relating to meetings are not necessarily confined to the financial years in which they are held. The accounts overleaf contain receipts for one meeting to be held in 2013/14, and lack receipts for one or more of the meetings in the table below, as those payments occurred in 2011/12.
